Sub.: Sanction of financial assistance for Administering Road safety Advocacy-reg

Madam/Sir,

I am directed to refer to your proposal dated 10.09.2018 for administering Road Safety Advocacy under the scheme of Financial Assistance to NGO for Administering Road Safety Advocacy in Kanpur.

2. The same has been examined and the competent authority in the Ministry has agreed to grant financial assistance of Rs.5.00,000/- (Rupees Five Lakhs only) to your organization for administering one road safety advocacy programme in Kanpur subjected to the following:-

- I. As the scheme does not provide for any advance payment, the financial assistance will be reimbursed after completion of programme on receipt of requisite documents and programme completion/verification certificate as per the provisions under the scheme from ASRTU, New Delhi.
 - II. Simultaneously, the organization will also upload the proposal on the scheme's portal at link <http://morth-roadsafety.nic.in:8080/morthngogrant/mairgonsoft/commonui/login.xhtml>.
 - III. Agency will start the programme at the earliest in the current financial year 2018-19.
 - IV. The agency will intimate the dates & venues of the activities to the PMU i.e Association of State Road Transport Undertakings (ASRTU), New Delhi, Plot No.4A, PSP Block, Pocket 14, Sector-8, Dwarka, New Delhi, India-110077, Phone No.01143294294, email ID ed@astru.org and the Ministry well in advance of the date of start of the programme with programme schedule so that PMU can make necessary arrangements for visit/inspection of the programme.
 - V. After completion of the programme, the agency will send Audited utilization certificate in GFR 12A, audited statement of accounts, physical performance report containing brief of activities conducted, beneficiaries, photographs and videos of the programme to the Ministry.
 - VI. Financial assistance will be restricted to road safety activities as proposed by organisation in original application and it should be as prescribed under the scheme guidelines. Further, it is also cleared that any salary or any moveable or immoveable assets related expenses are not reimbursable under the scheme.
 - VII. ASRTU, New Delhi has been nominated as Project Management Unit (PMU) for the said scheme.
