This is to inform you that you have been empaneled "provisionally" for the above-mentioned work in want of following information/consent/documents, to be submitted latest by 13-02-2021, Saturday, 1700 Hrs through e-mail.

- 1- It is requested to submit your consent, required as per provisions of Sub Para 6.4 and 6.5 of RFP Document to work at the rate of Rs. 3,30,000.00 (Rs. Three Lacs Thirty Thousand), excluding GST, per GP as has been approved by Evaluation Committee. Kindly submit your consent latest by 13-02-2021, 1700 Hrs through e-mail, failing which shall be considered as denial of offer and you not shall be considered for further process.
- 2- It is requested to submit your choice of districts, in order of preference, for all the 10 districts namely, Mahoba, Jhansi, Banda, Hamirpur, Chitrakoot, Lalitpur, Muzaffarnagar, Shamli, Baghpat and Meerut. However, work may be allotted by SPMU in any of the districts consisting of set of GPs (Cluster) as has been mentioned in RFP Document Sub Para 6.5 and 6.6.
